Sub: TSBIE – Academic – Vocational Education +2 Stage scraping of old Question Paper pattern of the academic year 2012-13 & providing the last chance for the backlog Candidates for the IPE-2024 & IPASE 2024 -Reg.

With reference to the subject and reference cited, all the Principals/ Managements of Junior Colleges offering Vocational Courses and the Candidates who studied Intermediate Vocational Courses before academic year 2012–13 and had backlog subjects, i.e., **English, General Foundation Course (GFC), and On-the-Job Training (OJT)** are hereby informed that certain changes have been made to the question paper pattern and maximum marks for the following subjects as below:

Intermediate Vocational Theory Examinations – Marks Allocation Pattern (All Courses)			
Sl. No.	Name of the Subject (for I & II Year)	Before Academic year 2012-13 (Max. Marks)	From the Academic Year 2012-13 onwards (Max. Marks)
1	English	75	50
2	General Foundation Course (GFC)	75	50
3	On the Job Training (OJT)	50	100

Further, it is to inform that, every year certain cases were observed, wherein the Candidates who were studied Intermediate Vocational Courses before academic

year 2012-13, but have backlogs, are still appearing for Intermediate Public Examinations. They are writing examination as per the new pattern and due to which the marks scored are being converted into the previous pattern and accordingly, manually prepared Intermediate Marks Memos/Pass Certificates are issued to the Candidates.

But, when the Candidates are appearing for Higher Education (or) taking up jobs, the certificate validation/issue of equivalency certificate has become complicated, as most of the Universities/Colleges at graduation level are familiar with the new pattern of marks allocation i.e., the pattern which came into force from the academic year 2012-13. Despite, the change/upgradation of syllabus from time to time, upgradation of marks allocation, question paper pattern, the previous pattern is still being continued.

In view of the above, the candidates who studied Intermediate Vocational Courses before academic year 2012-13 and had Backlogs in **English, GFC and OJT** are **given final chance** to appear for the Examinations both for **IPE- 2024** and **IPASE 2024** and get the backlogs cleared.

Therefore, from the next academic year 2024-25 onwards, such candidates appearing for such examinations have to write all the examinations in the new pattern only.

Further, all the Principals/Managements and District Intermediate Education Officers are hereby requested to give wide publicity in this regard.
