Sub: - INTERMEDIATE EDUCATION - Vocational Education +2 Stage- "On Job Training" to the Vocational Students of the Junior Colleges in the State for the academic year 2023-24 - Guidelines - Issued.

Ref: Proceedings of this office, CIE-SIVE/OJT/1/2022-SIVE, dated: 24.11.2022

All the District Intermediate Education Officers/Nodal Officers in the State are directed to conduct On Job Training for both 1st and 2nd year students of Vocational Courses at +2 level for the Academic Year 2023-24. Further, "On Job Training" may be held in the months of "NOVEMBER & DECEMBER 2023 [02 Months]". The guidelines to be followed are mentioned hereunder:

GUIDELINES/INSTRUCTIONS FOR ORGANIZING ON THE JOB TRAINING

- On Job Training is back bone for Intermediate Vocational Courses. It provides double benefits to Vocational Students. It equips the students with suitable skills and also makes a perfect path for future.
- The Principals of GJCs are requested to appoint the Junior Lecturers dealing with Vocational Courses as Vocational Coordinators for each course who will assist in the arrangements of On-the-Job Training.
- They are requested to approach the identified firm/agency/establishment where Vocational students can be placed on OJT and take their consent.
- In consultation with the identified firm/agency/establishment, Vocational Coordinator has to fix up the schedule of the OJT i.e., duration, commencement, training schedule, evaluation etc., and in case of any difficulty, they are requested to take help of the District Intermediate Vocational Education Officer/Nodal Officer while arranging the OJT.
- Once the schedule is finalized, instructions have to be issued to the students to attend the OJT compulsory to get Practical knowledge/hands on experience.
- The Vocational Lecturers will have to attend the OJT program on all days.
- The duration of the OJT can be organized in any time during the academic year/ during November - December months.
- The principals are further requested to make frequent visits to OJT centers and monitor the program.
- They are requested to provide the necessary raw material for conduct of the Practical at the site, if necessary.
- At the end of the training, the students' performance shall be evaluated jointly by the Vocational Coordinator and the trainer of the firm for maximum marks of 100. The award lists in the prescribed Proforma shall

be submitted to the Secretary, Telangana State Board of Intermediate Education on or before 20th January 2024.

EVALUATION OF ON THE JOB TRAINING

e] "On the Job Training" shall carry 100 marks for each year and pass marks is 50. During OJT training the candidates shall put in a minimum of 90% of attendance. The evaluation shall be done in the second week January.

f] The spirit of On-the-Job Training is to be maintained. The Colleges are at liberty to conduct On the Job training according to their local feasibility of institutions & industries. They may conduct the entire on the Job Training period of 02 months either by conducting classes in the morning session and send the students for OJT in the afternoon session or two weeks or weekly or monthly or by any feasible mode for both the College and Institution. However, the total assigned periods for On-the-Job Training should be completed.
